# **Old Business:**

- > Yard of the Month The yard of the month sign will need to be picked up and a new yard picked-Ronda to do that today.
- Christmas Decoration Contest Gift card amounts will be \$50 for first place, \$35 for second place, and \$25 for third place. Judge date will be on December 18<sup>th</sup> with board members to send their top 3 picks to Aldo by that time. Aldo to send a reminder for this.
- > Senate Bill 1588 Several questions were asked at the community meeting and Marie provided a follow up. As of September 1, 2021, anyone already on the board is also part of the architecture board is grandfathered into this law. Any new member added to the board after September 1, 2021 cannot be on the board and on the architecture board. They must be on one or the other. In order to move from one board to the other, an official resignation letter must be presented and accepted. One spot is currently open for

the architecture board, Marie to check with a few other homeowners to see if they want to volunteer for the architecture board. Board can appoint the members of the architecture board.

- ➤ Huffmeister streetlight A homeowner requested the precinct to do a study on the streetlight at the entrance of the neighborhood (homeowners have complained about this intersection being dangerous when exiting our neighborhood). The study was turned down but there has been a yield on left sign put up on the sign itself.
- ➤ White Oak Falls Court construction Erika discussing the replacement of the fence at the north end of White Oak Falls court. It looks bad and needs to be replaced. Erika will report back.

- ➤ Water meter online monitoring Following the install of the new water meters, there will be a new software so the homeowners will be able to access them with an online account. Marie to follow up on.
